On August 18, 2026, the SEC took its most historic step toward modernizing digital market rules by proposing Regulation Crypto Assets. By shifting from a policy of regulation by enforcement to a codified set of exemptions and safe harbors, the SEC has provided clear parameters that public company boards, founders, and advisers need to structure compliant offerings..
